

The presentation of the articles must be accompanied by a letter of declaration of originality and a commitment not to present simultaneously in another journal / s signed by the author (s).

The articles must respect the APA standards, adjusting to the following guidelines:

Articles on scientific research, teaching or extension activities, or reflection on a particular problem or topic may have a maximum length of 20 pages, notes up to 15 pages and interviews, reviews or comments on books, publications or scientific events. up to 3 pages. The latter will refer to recent publications of interest to the magazine. In all cases, the sheet size will be A4, spacing 1.5. The article must be sent in Word word processor format by email [polifoniasrevistadeeducación@gmail.com](mailto:polifoniasrevistadeeducación@gmail.com)

The article will be headed by the title (in Spanish and English) and the full name of the author. It will also include 5 keywords and a summary (in Spanish and English) that does not exceed 200 words. In a cover page, independent of the text, the title of the article, the name of the author (s) and the following information will be placed: professional title of the authors, if applicable, institutional membership, academic position, postal address, telephone number and electronic address. All pages must be numbered, including the bibliography, graphics and tables. Critical notes and references should go at the foot of the page and respect international standards for the publication of scientific articles.

The Bibliography must appear at the end of each article and will be adjusted to the following conditions: - Book: Author's last name and initial in capital letters, year of publication in parentheses, title of the book in italics, place of publication, publisher. - Journal article: surname and name of the author in capital letters, year of publication in parentheses, title of the article in quotation marks, title of the journal in italics, volume, number of the journal, date of publication, pages that the article includes within Magazine. - In the event that charts, graphs and / or images are included, a title and numbering must appear in the text: "Graphic nº 1: xxxx", a blank space in which the chart, graph and / or image would go ( but without placing), and the source: "Source: xxxx" (if they have been made by the author they should say "Source: own elaboration"). Tables, graphics and / or images should be sent as separate files from the text, in any format that supports them.

It is recommended that a hierarchy logic of the titles be respected as follows: Titles: Arial, body 14, bold Subtitle 1: Arial, body 12, bold Subtitle 2: Arial, body 12, italic Body of text: Arial, body 11, normal Notes: Arial, body 10, normal Bibliography: Arial, body 10

Regarding the citations within the text, the APA standards are taken as a reference:

- References to authors in the text should be made as follows: Author's name, comma, year of publication. In cases where the author's name is mentioned, it will suffice to write the year of publication of the work referred to in parentheses.

- In the event that the work has two authors, the reference will be made in the same way as described above, but citing both authors.

- In the case of three or more authors, all of them will be cited the first time their work is referenced. Thereafter, only the first author's last name will be used, followed by the acronym et al. and then the year of publication.

- Quotations of four lines or less may be followed in the text, using quotation marks to indicate that it is a textual citation. At the end of the citation, the number or page numbers in which the original text appears will be indicated in parentheses.

- If the appointment is more than four lines, the appointment will be made with an indentation of 1.5 on each side. This type of quote is not enclosed in quotation marks. At the end of the quote, the page number or numbers in which the original text appears will be written in parentheses.

In the case of citations within the text, the following criteria will be respected: the citations of less than 40 words will be placed in the body of the text. They will be placed in quotation marks and followed by the author's last name, the year of publication and the corresponding number or numbers of pages in parentheses. When the cited author integrates the paragraph, only the year and the number of pages will be placed in parentheses. Quotations of more than 40 words will be highlighted in a separate paragraph and centralized with an indentation of 2 centimeters on each side. Untitled references will be incorporated in the paragraph in parentheses, specifying the author and year of publication of the work.
